THE CORPORATION HAS BEEN INCORPORATED TO CARRY OUT PROCUREMENT, SUPPLY & DISTRIBUTION WORK OF MEDICINES, EQUIPMENTS ETC. IN THE STATE OF CHHATTISGARH ON BEHALF OF VARIOUS DEPARTMENTS. FURTHER, AS PER DECISION OF THE GOVT. OF CHHATTISGARH, THE CORPORATION HAS TO CARRY OUT ALL CONSTRUCTION WORKS RELATED TO HEALTH DEPARTMENT OF CHHATTISGARH.

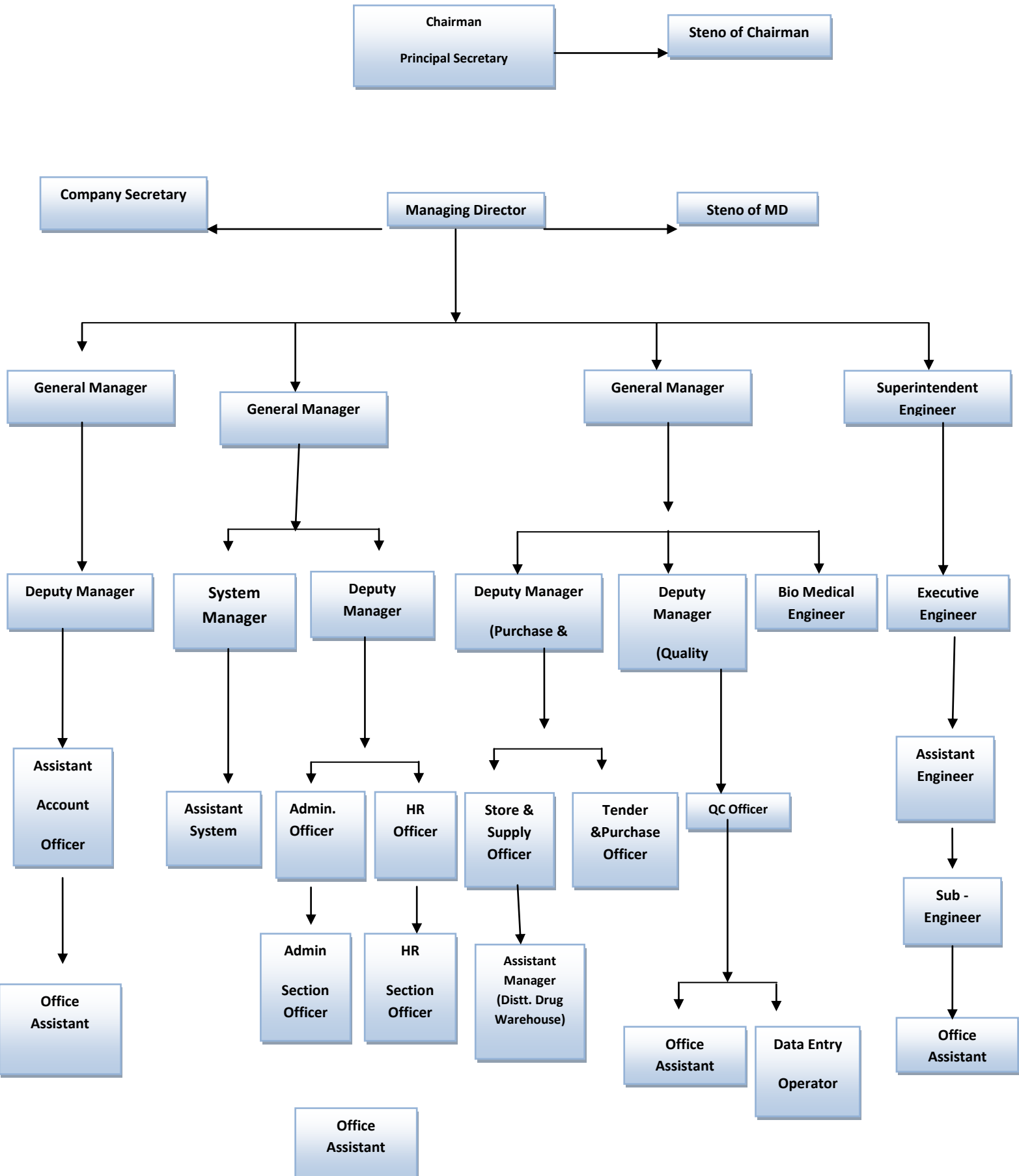
